

WAIVER OF LIABILITY, RELEASE, ASSUMPTION OF RISK & INDEMNITY AGREEMENT

For and in consideration of PARTICIPANT'S registration with Rocky Mountain Roller Hockey League Inc., and being allowed to participate in RMRHL events and team activities, the parent(s) or legal guardians(s) of PARTICIPANTS and the undersigned relinquish any and all liability for and cause of action for personal injury, property damage or wrongful death occurring to PARTICIPANT arising out of participation in RMRHL events or team activities or the sport of inline hockey, or and activities incidental thereto, wherever or however they occur and for such period said activities may continue, and by this agreement any such claims, rights, and causes of action that PARTICIPANT may have are hereby relinquished and the PARTICIPANT (or parent(s)/guardian(s) does (do) so on behalf of my/our and PARTICIPANT'S heirs, executors, administrators and assigns.

PARTICIPANT and/or participant's parent(s)/guardian(s) acknowledge, understand and assume all risks inherent to inline hockey and any team activities, and understand that said sport and activities involve risks to PARTICIPANT'S person including bodily injury, partial or total disability, paralysis, and death, and damages which may arise there from and that I/we have full knowledge of said risks. These risks and dangers may be caused by the negligence of the PARTICIPANT or the negligence of others, including the "RELEASEES" identified below. It is further acknowledged that there may be risks and dangers not known to us or are not reasonably foreseeable at this time.

PARTICIPANT and/or participant's parent(s)/guardian(s) acknowledge, understand and assume the risks, if any, arising from the conditions and use of inline hockey rinks and related premises and acknowledges and understands that included within the scope of this waiver and release is any cause of action, arising from the performance, or failure to perform maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at said rinks, for negligent selection of certain RELEASEES, or negligent supervision or instruction by RELEASEES.

IT IS THE PURPOSE OF THIS AGREEMENT TO EXEMPT, WAVE AND RELIEVE RELEASSEES FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, AND WRONGFUL DEATH CAUSED BY NEGLIGENCE, INCLUDING THE NEGLIGENCE, IF ANY, OF RELEASSEES.

"RELEASEES" include Rocky Mountain Roller Hockey League Inc and USA Hockey Inline, and their respective affiliate associations, local organizations, sanctioned league, sanctioned tournament organizers, member teams, event hosts, other participants, leaser's of premises, coaches, officials, volunteers, sponsors, advertisers, and each of them, their officers, directors, agents and employees.

PARTICIPANT or participant's parent(s)/guardian(s) agree if any claim for PARTICIPANT'S personal injury or wrongful death is commenced against RELEASSEES, he/she shall defend, indemnify and save harmless RELEASSEES from any and all claims or causes of action by whomever or wherever made or presented for PARTICIPANT'S personal injuries, property damage or wrongful death.

PARTICIPANT or participant's parent(s)/guardian(s) authorize Rocky Mountain Roller Hockey League, Inc to use PARTICIPANT'S name and or likeness, without compensation, in photography, video, or any of formats for publication, sale, production, and advertising in connection therewith, or any other use.

PARTICIPANT AND/OR PARTICIPANT'S PARENT(S) /GUARDIAN(S) ACKNOWLEDE THEY HAVE READ THE ABOVE PARAGRAPHS AND HAVE NOT RELIED UPON ANY REPRESENTATIONS OF RELEASSEES, THAT THEY ARE FULLY ADVISED OF THE POTENTIAL DANGERS OF INLINE HOCKEY, FULLY UNDERSTANDING THAT THE PARTICIPANT AND/OR PARTICIPANT'S PARENT(S)/GUARDIAN(S) HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT VOLUNTARILY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY THE LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THAT THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
